PROFIT WARNING

This announcement is made by Wan Leader International Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10(2)(a) of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors of the Company (the “**Directors**”) wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that based on the latest review of the Group’s unaudited consolidated management accounts for the nine months ended 31 December 2018 and information currently available to the Company, the Group is expected to record a net loss of approximately HK\$12.1 million for the nine months ended 31 December 2018 (as compared to a net profit of approximately HK\$7.3 million for the nine months ended 31 December 2017).

The turnaround from profit to loss was mainly attributable to the effects of (i) one-off listing expenses; (ii) increase in the acquisition costs of air cargo space; (iii) increase in rental expenses due to the relocation of warehouses and offices; (iv) increase in staff costs and benefits as a result of raises in basic salary, bonus and additional headcount added; and (v) an impairment loss on trade receivables.

The Company is still in the process of finalising the consolidated results of the Group for the Review Period. The information contained in this announcement is only based on the preliminary assessment made by the Board on the unaudited consolidated management accounts of the Group for the Review Period and the unaudited information currently available to the Company, which have not been confirmed or reviewed by the Company's auditor and the Company's audit committee. The above information may be subject to further adjustment based on further updated information and following the completion of the review by the Board's audit committee.

Shareholders and potential investors are advised to read carefully the quarterly results announcement of the Group for the Review Period, which is expected to be published in February 2019.

Shareholders and potential investors should exercise caution when dealing in the securities of the Company.
