PROFIT WARNING

This announcement is made by Wan Leader International Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10(2)(a) of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders (the “**Shareholders**”) of the Company and potential investors that, based on the preliminary assessment of the Group’s unaudited consolidated management accounts for the nine months ended 31 December 2019 (the “**Period**”) and information currently available to the Board, the Group is expected to record a net loss before taxation not exceeding HK\$17.0 million for the Period (as compared to a net loss before taxation of approximately HK\$1.8 million (excluding listing expenses) for the respective period in 2018 (the “**Previous Period**”)).

The increase in loss was mainly attributable to the effects of (i) increase in the costs of air and sea cargo space; (ii) legal and compliance costs, professional fees and printing charges incurred after the listing of the Company’s shares on GEM ; and (iii) increase in warehousing services related cost including subcontracting charges such as palletisation and trucking services and depreciation.

The information contained in this announcement is only based on the preliminary assessment made by the Board on the Group's unaudited consolidated management accounts of the Group for the Period and the information currently available to the Board, which have not been confirmed or reviewed by the Company's auditor or audit committee. As the Company is still in the process of finalising the consolidated results of the Group for the Period, the above information may be subject to necessary adjustments.

Shareholders and potential investors are advised to read carefully the third quarterly results announcement of the Group for the Period, which is expected to be published by around mid-February 2020.

Shareholders and potential investors should exercise caution when dealing in the securities of the Company.
