### **POSITIVE PROFIT ALERT**

This announcement is made by Wan Leader International Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10(2)(a) of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders (the “**Shareholders**”) of the Company and potential investors that, based on the preliminary assessment of the Group’s unaudited consolidated management accounts for the three months ended 30 June 2020 (the “**Period**”) and information currently available to the Board, the Group is expected to record a net profit before taxation not exceeding approximately HK\$4.4 million for the Period (as compared to a net loss before taxation of approximately HK\$4.5 million for the respective period in 2019).

The expected turnaround from loss before taxation to net profit before taxation was mainly attributable to the effects of (i) improvement in the gross profit of the Group, which was mainly attributable to the increase in revenue generated from air freight forwarding and related logistics services and warehousing and related value-added services during the Period; and (ii) government subsidies received during the Period.

The information contained in this announcement is only based on the preliminary assessment made by the Board on the Group's unaudited consolidated management accounts of the Group for the Period and the information currently available to the Board, which have not been confirmed or reviewed by the Company's auditor or audit committee. As the Company is still in the process of finalising the consolidated results of the Group for the Period, the above information may be subject to necessary adjustments.

Shareholders and potential investors are advised to read carefully the first quarterly results announcement of the Group for the Period, which is expected to be published by around mid-August 2020.
