**VOLUNTARY ANNOUNCEMENT**  
**COMMENCEMENT OF FREIGHT FORWARDING AND COURIER**  
**LOGISTICS SERVICES IN THE UNITED KINGDOM**

This announcement is made by Wan Leader International Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) on a voluntary basis. The purpose of this announcement is to keep the shareholders of the Company and potential investors informed of the latest business development of the Group.

The board of directors of the Company (the “**Board**”) is pleased to announce that after preliminary research, analysis and other preparatory works, the Group intends to commence freight forwarding and courier logistics services in the United Kingdom (the “**New Expansion**”).

**Reasons for the New Expansion**

The Group is primarily engaged in (i) the provision of freight forwarding and related logistics services of airlines, shipping liners and other freight forwarders in Hong Kong and (ii) provision of entrusted management services for operating an online e-commerce platform.

Since providing the entrusted management services for the online e-commerce platform, the Board has noted that there is a growing demand between Hong Kong and the United Kingdom for courier logistics services. This is particularly the case since the commencement of Brexit and the change of immigration policy in the United Kingdom.

Having considered (i) the demand for freight forwarding and courier logistics services between Hong Kong and the United Kingdom will continue to grow; (ii) the trend for such services will likely continue in the foreseeable future; (iii) the existing logistics networks and contact of the Group can help to establish the New Expansion; and (iv) such New Expansion is in compliment to other existing businesses of the Group, the Board believes it is the time for the Group to expand its footprint beyond Hong Kong and to seize the opportunity of any potential business in the United Kingdom.

The Board is currently in the final stage of formulating the business plan for the New Expansion. No definite agreement has been entered into between the Group and any parties as of the date of this announcement. Consequently, the New Expansion may or may not proceed due to various commercial, technical or local regulatory issues. In this regard, the Board is not yet in a position to assess the financial impact of the New Expansion and related business initiatives on the Group in the short or long term.

**The Board may issue further announcements in relation to the New Expansion in accordance with the GEM Listing Rules as appropriate. Shareholders and potential investors of the Company are cautioned not to unduly rely on the above information and are advised to exercise caution in dealing in the Company's securities.**
